Texas Business and Commerce Code, if a check or money for repair on the vehicle is stopped, dishonored because of insufficient funds, no funds or because the drawer or maker of the check or money order has no account or the account on which it is drawn has been closed. I also authorize an express power of attorney for any form of payment for the service and/or repair of this vehicle listed herein.

The undersigned Purchaser further agrees that the warranties excluded by the dealer, include, but are not limited to any warranties that such part and/or accessories of merchantable quality or that they will enable any vehicle or any of its systems to perform with reasonable safety, efficiency, or comfort.

A storage charge of \$40 per day will be assessed to any vehicle that is not repaired. The same fee will commence on the third day following the completion of the repairs or services to any vehicle.
